Subject: Complaint Report in regards to Mr. Chungjalen Thangedo.

Regarding illegal encroachment/occupation and looting household properties of my residential house at Dewlahland Imphal East under Patta No.419(New) Village No.25(A) Kabo Leikai Nongpok by Arambai Tenggol.

Sir,

I the undersigned would like to state few lines before your kind consideration and sympathetic action regarding the cited subject above. That we were staying in our own Pucca Building with 3 storage building at Dewlahland, Imphal East, 1st Lane Opposite Christian Hospital. But on 4th May 2023 around 12:30pm we had to leave our homes due to prevailing law and order situation and we were compelled to take shelter at 2nd M.R Battalion till 8th May 2023 afternoon after which we were escorted till Kangpokpi by the A.R Personnel. On 12th APRIL 2024, I came to learn through one of my neighbours that all my household properties were looted by Arambai Tenggol. After all our properties being looted by the Meitei Terrorist, and the so Called MEITEI LEEPUN & ARAMBAI TENGOL they illegally occupied my entire house. Our two wheeler vehicle (Royal Enfield) which was also among those being left behind has been under their position.
