Sir,

I have the honour to report today, i.e., 23/04/2024 at about 12:10 am received an information regarding some unknown persons were reportedly stealing some household items from the abandoned houses located in and around New Lambulane/New Checkon area. Accordingly, a team of Porompat-PS led by me rush to the said area to effect arrest the unknown persons. On reaching at New Checkon Bazar found that, two unknown person were coming from 2nd street New Lambulane proceeding toward New Checkon Crossing in a four wheeler vehicle super AC bearing Regd. No. AS16C-3485 in a very suspicious manner loaded with some suspected stolen items. Immediately, the Police team stopped the Super AC vehicle bearing Regd. No. AS16C-3485 for verification at New Checkon near NCYC Club, Imphal East. On spot verification, the unknown duo person are identified themselves as Oinam Deben Meitei (56) S/o late O. Nawang Meitei of Torbung Maning Leikai, Churachanpur A/P New Lambulane 2nd Street, Imphal East and Sagolsem Nopur Singh (42) S/o S. Jayenta Singh of Hiyangthang Maning Awang Leikai. On further verification, they stated that the said household items was stolen from unknown abandoned houses of New Lambulane 2nd street areas. So, the stolen items along with Super AC vehicle bearing Regd. No. AS16C-3485 were seized thereby arrested the duo person and brought at PS for further necessary action.




