I have the honour to report that today i.e., 23/04/2024 at about 12:00 pm, it came to light from one Face book page " PAMHEIBA MOIRANG " quoted on his Facebook that " Wangkhei da Gunda Ama Leirido Ahan Laman mashak khanga chatlu ngamdra de Nashage mongfam thiba oina thokani" literally meaning is on who imitating as Barish projectile as a self-style gunda, If it had been done by one civilian the said Biren tengol could have reacted and even caused to death as any action could not be taken up against him, which darelly shows that he is one among the said gunda/gang. who is claiming and denounce as SOREPA group and another Facebook page namely Ningtamba Khuman uploaded on his Facebook page as " Barish sariba guda se micham amana saramba oi u noi Biren Tengol na phubada c raroidro.... mangonda keim hyba ngamde aduna takpadi noi gunda masen ni takpa ntro" literally meaning is A gunda of Wangkhei is warn to followed the superior or elders, if he couldn't keep, he is seeking himself for death. who is pronounce and claiming to be a group RPF party.

The above pages posted by SOREPA and RPF is an act of humiliating, intimidation and tarnishing the images against me and Hon'ble Chief Minister N. Biren Singh.

It is, therefore, requested to kindly take up necessary legal action against the above noted persons according to law.





