No. 32 & Village No. 26(A)-Nongpok Inkhol under Porompat Sub-Division at New Lambulane 2nd Street, Imphal East District, Manipur . However, the exact date and time of the incident could not be ascertained. The approximate worth of the looted/plundered/damaged is estimated at Rs. 2,37,71,200/-.

It is therefore, requested you kindly to look into the matter and take up a

necessary legal action as per the law of the land.
