I would like to mention that we belong to the Thadou tribe. Our residence is located in New Lambulane, River-Side, Opposite Dimdailong Main Gate in Imphal-East district under PO. Porompat Police Station. My family last stayed in our home till the moment they were evacuated in the wee hours on September 2, 2023. Till then our locality was being manned by the RAF teams stationed there in connection the communal violence which started since May 3, 2023.

That, We had hoped that the RAF being stationed in our locality would deter possible crimes but unfortunately that didn't turn out to be the case as facts would have it. And on the 14th April 2024 it has come my knowledge that some unknown Meitei Miscreants have broken into our house and occupied without our consent. All the household items have been stolen and some are sold in online Facebook Market. web page name "Olx Manipur Kangleipak" by one Active Online marketer member namely Ppegasus Spyware and Facebook user Name :- Ppegasus Spyware.

The delay in this report is mainly due to the fact we were not aware of the situation developing in the area.

Therefore, I request the relevant authorities to file an FIR and for further legal necessary action.
