We are to report herewith that on dated 26th April 2024 between 09:54 A.M to 10:00 A.M., a N Manipuri youth along with his team had withdrawn cash from the NCR ATM bearing ID MSCN000 installed at our Imphal East Branch amounting to Rs.20,000/- (Rupees Twenty Thousand) only tempering with the help of his finger on the said NCR ATM resulting to manipulation to its Electron Journal Transaction recorded in the said ATM. As evidence of this transaction, we are submitted herewith the Video footage along with Electronic Journal recorded by the said ATM reflecting unus error transaction for your perusal.

By manipulating to ATM transaction, he will submit a written complaint for not dispensing cash this ATM to the concern bank branch in which his account is maintained though amount has b received by him. Proper transaction also seen in the account statement as enclosed.

In this ATM, such similar incident was also happened on dated 24th April 2024 between 9:59 A.M. 10:25 A.M. and between 02:56 P.M to 02:59 P.M by another person thereby withdrawing Rs:70.0 (Rupees Seventy Thousand) only. Now, complain has raised by card issuer Bank on behalf of til customer to our Bank for not receiving cash from the ATM as highlighted in Para No. 2 above. related Electronic Journal and video footage for successfully taken cash is also submitting herevy along with complain raised by the card issuer bank. ting to Bolden albeid

We therefore request you to kindly look into the case and bring the perpetrators to justice at the earliest possible.
