ethnic crisis in Manipur.
- (2) That on 19th April 2024 I have received an information from the House Owner
and other reliable sources that, the house had been looted and plundered by
unknown miscreants. However, the exact date and time of the incident could
not be ascertained. The approximate worth of the looted / plundered
damaged goods and properties is estimated at Rs. 800,000/-.


It is therefore requested you to kindly look into the matter and take up necessary






