Subject:- First Information Report.

Sir,

I will be highly obliged; if you kindly draw your valuable attention to the following few facts for your consideration and necessary prompt action. That, today i.e. on 19th April, 2024 at around 9:30 A.M. at the 6/3 Kyamgei Awang Leikai, while I was working as a polling agent of the Indian National Congress Party for the ongoing election of the I-Inner Manipur Parliamentary Election 2024, to the 18th Lok Sabha. Some people came to the polling room and started casting proxy votes to which I interfered and objected as the same was illegal. Thereafter, the people wearing black uniform called me out to which I did not react. Thereafter inside the polling room around 40 to 50 armed with sophisticated weapons miscreants came in and dragged me out of the polling room and started assaulting me by kicking and punching me. They also threatened me to stay in my house with a warning if I came out I will be shot dead. I came to my house and stayed for a while. After some time the same people came to my house breaking my front gate and fired around 7 to 8 rounds of ammunition at my house. And they shouted that if I came out of my house I will be shot dead and my house will be burnt down. Thereafter they left my house.

I am requesting your good self to kindly take up necessary legal action against the culprits.
