That, on 30/04/2024 at around 4.30 pm one Loitongbam Imobi Singh @ Ingobi Singh aged about 67 yrs. s/o Late Loitongbam Madhop Singh A/p Kontha Ahallup near Om-Shanti and Bisleri Water Package Facility, P.O. Mantripukhri, P.S. Heingang, Imphal East District (Permanently at Moreh Ward No. 6 P.O. & P.S. Moreh, Tengnoupal District, Manipur) along with his hired persons forcefully came to my resident located at KhongmanZonent East, and destroyed/vandalized CCTV Camera, gate, broke all the locks of my residential house and my factory (i.e. MS Moirangcha Enterprises package Drinking Water) which is just adjacent with my resident house without giving any reasons and forcefully displaced us.
