SUBJECT: APPREHENSION OF SUSPECTED UNLF (K) CADRES

Respected Sir,

1. Based on the credible intelligence about an arms dealer operating in Ukhrul town, troops of Assam Rifles in a joint operation with Police representatives carried out swift search operations at present address Viewland Near Infront Jesus English School Ukhrul Dist Manipur the residence of the accused Mr Huidrom Jitanjit Singh, 36 yrs resident of Sekmaijin Mamang Leikai Hiyanglam, Thoubal Manipur and Mr Ningthem Oinam, 43 yrs Thangkarang Bishenpur, Manipur vilage on the intervening day of 08 May 2024. The search operation resulted in seizure of Rs 1,74,840/- in cash, 02 x Walkie – Talkie and quantity 40 rounds of 6.9 mm ammunition of various calibre. The operation was undertaken with effect from 1130 hours on 08 May 2024 and was culminated at 1500 hours on 08 May 2024. On searching the residence and the premises, the following items were seized from the above mentioned individual:-
