

Today i.e. 11/04/2024 at 1:10 pm received an information that on the same day at about 1:00 pm one Bolero Jeep driven by unknown driver coming from Thoubal side towards Yairipok side along Yairipok Thoubal road collided to a Diesel Auto coming from opposite direction due to rash or negligence driving on the part of Bolero Driver at Wangkhem Bazar along Yairipok Thoubal road. There after the same Bolero hit again to a Honda Activa which was coming behind the Diesel Auto due to uncontrol by the driver. Resulting the driver and occupants of the Diesel Auto and rider of the Honda Activa sustained injuries on their persons and evacuated to the Hospital for medical treatment. All the three vehicles i.e. Bolero, Diesel Auto & Honda Activa were also partly damaged.

Hence a sou-motto case under FIR No. 20(04)2024 YPK-PS u/s 279/338/427 IPC has been registered for investigation.
