




Sir,

Nanao Singh of Phoudel Moirangpalli were at the house of Nahakpam Modhumangol Singh S/o (L) N.Tombi Singh of Phoudel Moirangpalli to fill up the agent form for the upcoming Lok Sabha Election 2024, some unknown armed person numbering about 5/6 came and forcibly took away the following articles on gun point i.e. 1) BJP wall poster, 2) Agent form, 3) Electoral roll, 4) 3(three) Mobile phone i.e. (i) POCO X2 having mobile No. a) 7005150081 (JIO) & b) 8794283514 (Airtel) (ii) MI Note 13 having mobile No. 8787352388 (JIO) (iii) Realmei 8S having mobile No. 9862925374 (JIO), 5) Rs. 7,000/- approx. in cash from N. Rohilkumar Singh, 6) A purse containing Rs. 40000/- approx. in cash, ATM cards, driving license, voter card, Aadhar card & receipts memos from me. The said unknown person also assaulted us.

It is therefore requested to kindly taken up necessary action against the unknown armed persons accordingly.


