




Sir,

With respectfully, I to report that on 18/04/2024 around 9:30 pm some unknown persons came on two car (Red and White Car) with Sophisticated arms and threatened to my family with saying some words "Why do you run for BJP? If you have to further run to the BJP Party you and your family will be kill". And also damaged two stand posters of BJP. The following articles were also forcibly taken away the unknown persons i.e. Rs. 10,000/- (ten thousand), Electoral roll of polling no. 32/15, Agent form, voter slip. Further, my youngest son namely, Ijajul Haque Singamayum aged about 24 years was grabbed his arm and pulled about 50m and pulled inside a car and interrogated around 10 minutes and released. They also assaulted my son.

So, I request you to kindly taken up necessary legal action.
