Respected Sir,

I, Nengneikim Haokip aged about 29 years, W/O Seikhopao Haokiip a resident of Hengjang village, P.O. Kangchup Geljang, P.S. Gamnom Sapormeina, Kangpokpi District, Manipur, currently seeking refuge at the Lhangnomphai Relief Camp, Kangpokpi District, Manipur. I am writing to bring to your notice that since May 6th, 2023, a Meitei mob, purportedly associated with Arambai Tenngol and Meitei Leepun attached my village, attempting to set it ablaze. The situation escalated on May 7th, 2023, when all residences in our village were set on fire, forcing my family and fellow villagers to flee for our lives and seek shelter in the jungle. Through divine providence, we reached Lhangnomphai Village on May 7th, 2023, where we were aided by NGOs in registering at the Lhangnomphai village, Relief Camp, on May 8th, 2023.

During this tumultuous period. I was one month pregnant. However, upon reaching the Lhangnomphai Relief Camp, I underwent a medical examination at the PHC, Kalapahar, Kangpokpi District which revealed that I had suffered a miscarriage due to the profound mental trauma inflicted by the ongoing conflict. *Enclosed herein are the medical documents* verifying this diagnosis. The loss of my unborn child has taken a significant emotional toll on me, compounded by the distress of being displaced and without a home.

Given these circumstances, I urge your esteemed office to take swift legal action against the perpetrators to ensure justice is served. As an internally displaced person grapping with emotional trauma, I was unable to report the incident promptly.
