





Sir,

As per endorsement, I have conducted a discrete enquiry regarding the report of threat to life and property by Unlawful person to one Khagokpam Khamba Singh S/o (L) Kh. Udhob Singh of Khurai Awang Kongpal Laishram Leikai.

During the course of enquiry, visited the spot and examined the complainant who fully corroborated with the complaint report. On enquiry it is learnt that the complainant is a retired Additional Chief Engineer (Elect.) of the Electricity Department , Government of Manipur. Since his retirement, he have been actively involved in various developmental projects for the betterment of the community, serving as a dedicated social worker and he was a candidate in the last Manipur Assembly General Election in 2022 representing the 3-Khurai Assembly constituency.

On further enquiry it is also came to know that some unidentified individuals, numbering five in total and masked forcefully entered his premises who came in white Creta car without registration no. they brandished a handgun and issued threats to both his life and property. Moreover, the unidentified miscreants proceeded to take photographs of all the vehicle parked inside the complainant's residence, warning of intention to set them ablaze. It is also came to learnt that this incident bears a striking resemblance to the circumstances with the previous incident which already an FIR was registered at PRT-PS vide FIR No. 05(01)2023 PRT-PS u/s 20 UA(P) Act & 506 IPC.

During the course of enquiry it comes in light that when the unidentified miscreants came at the complainants residence the complainant did not meet the miscreants however one of his son namely Khagokpam Sanatomba @ Abung Singh (45) S/o (L) Kh. Ibobi Singh of Khurai Awang Kongpal Laishram Leikai personally meet them and allow them to speak through his mobile phone with the complainant. The CCTV footage of the said incident and the voice recording is also examined.

Recently on 15<sup>th</sup> April 2024, a text MSG is received stating that " NANG FAJANA WARI SANNABNA FANIKO NAYUMDA LAKLAMBA NUMIT




