



Subject :- Report.

I have the honour to report today, i.e, 17/04/2024 at about 10.20 received an information regarding some unknown persons were reportedly stealing some household items from the abandoned houses located in and around New Lambulane/ New Checkon area. Accordingly, a team of Porompat-PS led by me rush to the said area to effect arrest the unknown persons. On reaching at Checkon Crossing found that, one unknown person is coming toward Checkon from New Lambulane Tribal Market on a Auto Rickshaw RE bearing Regd. No. MN07-0928 in a very suspicious manner loaded with some suspected stolen items. Immediately, the Police team stopped the RE-Auto Rickshaw for verification. On spot verification, the unknown person is identified himself as Md. I. bencha Yumkhaibam (38) s/o (L) Md. Sher Mohamad of Kshetri Awang Leikai. On further verification, he stated that the said household items was stolen from unknown abandoned houses of New Lambulane area. So, he was arrested and seized the RE-Auto Rickshaw along with loaded stolen items and brought at PS for further necessary action.
