



Sir,

I have the honour to report that on 31/03/2024 at about 4 :00 pm my husband namely Md. Islam Khunlakpham aged about 60 years has been abducted by Amzad (40) years and Muktar Ahamed (40) years S/o late Md. Mirza of Hatta Golapati along with some unknown person. Later in the evening at about 7:00 pm it came to light that my husband has been brought to unknown places somewhere at Lilong area. Moreover, he was pointed on his head by gun and then dastardly beaten to my husband by using deadly weapons. My husband was threatening to kill and dire consequences will be meeting if he happened to disclose about the incident. Thereafter, he was evacuated to Public hospital Hatta for treatment.


It is therefore, requested to kindly take up necessary legal action against them according to law.
