


Dated : 19<sup>th</sup> April 2024.

In that one civilian got injured on his person. Due to the act of the unknown miscreants the public got furious and damaged the EVM machine and other equipments of the Polling booth. The injured person was later evacuated to Hospital for medical treatment.

Hence, the Suo-motto case under FIR No. 283(4)2024 PRT-PS u/s 307/326/506/34/171-C/171-E IPC, 123/136 RP Act & 25(1-B)A.Act is registered for investigation.




