- Sub: (i) Complaint against unknown persons for trespass, encroachment upon my property and forceful dispossession thereof, mischief, theft, and for disobedience of an order of a public servant;
 - (ii) A report/intimation of this Complaint to the Commissioner (Home), Govt. of Manipur.

Sir/Madam,

With regard to the above subject, I would like to state a few lines for your kind consideration and necessary action.

I, PaokhokaiKipgen, aged about 78 years, s/o (L) OnngulKipgen, a permanent resident of Silverspring Villa, Link Road 1, New Lambulane, Imphal East, Manipur, was residing in my house along with my family members when the ongoing ethnic clash broke out on 03.05.2023. As the situation deteriorated we were evacuated by the Assam Rifles on the morning of 06.05.2023 and eventually managed to reach safer locations. Since then I and my family members have been staying with our relatives. Till date, we are not able to retrieve any of our belongings valued at several lakhs of rupees.

Recently, in the last week of March 2024, I received information that unknown persons belonging to the Meitei community trespassed into my property, and havesince overtaken and settled in the houses situated therein, thereby effectively dispossessing me of my property. I also received information that several items have also been looted by unknown persons, prior to and during the takeover. The wall between my property and that of my neighbor's has also been reportedly brought down

for this nefarious purpose. Not only are these despicable acts punishable offences under the Indian Penal Code (IPC) but they also contravene the Order dated 10thOctober, 2023issued on behalf of the Governor by the Commissioner (Home), Govt. of Manipur(Copy enclosed). Notably, the violation of the said Order is also a distinct offence punishable under Section 188 of the IPC.

I, therefore, request you to register a zero FIR for trespass, encroachment, forceful dispossession, mischiefand theft under the relevant sections of the IPC. For violation of the Order dated 10thOctober, 2023, offence under Section 188 of the IPC may also be incorporated. Thereafter, the same may kindly be forwarded to the PS concerned (Porompat) at the earliest so that necessary action may be taken. I also request you, being in a position subordinate to the Commissioner (Home), Govt. of Manipur, to intimate/report to the aforementioned office of this Complaint. Your intimation/report to the said Office, as you may be aware, is imperative for initiation of proceedings vis-à-vis Section 188 IPC. heller to
