A large scale illegal excavation and transportation of earth materials both from the hill and valley portions within the Moirangkampu Sajeb Industrial Estate by some miscreants is reported now-a- day. Any activities of mining or excavation at Chingkei Ching Industrial Estate is treated as illegal as no any quarrying concessions has been granted in the area.

It may be recalled that with the constitution of "Dedicated Police Task Force(DPTF) under District Level Task Force vide Govt. of Manipur Orders No GM-1/2/2020, T,C&I dated 19-05-2022 monitoring and curbing of illegal mining is to be executed by DPTF(copy enclosed),, Further, at there is a total ban of all mining activities and transportation of minerals by an Order of the Hon'ble High Court of Manipur under PIL No. 5 of 2019.

This may kindly be treated as most serious.
