



With due respect, I the undersigned would like to seek your kind attention and necessary action.

That, due to the ethnic violence in the state starting from 3rd may, 2023, I was compelled to leave my house located at New Lambulane, 3rd Street, Imphal East under Porompat PS as I belong to Kuki community and left all my belongings inside the house under lock and key. I got an information that on 02-04-2024 at @ 10:30 am, some unknown miscreants suspected to be from the Meitei community forcibly entered my house and looted all the household belongings worth Rs 50,00,000/- (Rupees fifty lakhs) approximately.

I cannot report the matter in time as well as in my concern Police Station due to the volatile situation of the state.

In this regard, I request your goodself to take up necessary legal action against the culprits.
