With due respect, I, the undersigned, along with my family would like to state the following for your kind information and necessary action.

That. I along with my family, had left our residence at New Lambulane. 1st Street. Imphal on the 5th of May, 2023 before being evacuated to Kangpokpi on the 7th of May, 2023 for the safety of our lives due to the ongoing ethnic crisis in Manipur.

That, in pursuance of the order of the Hon'ble Supreme Court of India dated 25th September, 2023 directing the State Government to ensure protection of the properties of Displaced Persons and prevent their encroachments, the Commissioner (Home), Government of Manipur had issued an order No. H-3608/2/2023-HD-HD dated the 16th October, 2023 inthe name of the Hon'ble Governor of Manipur directing all relevant Deputy Commissioners and Superintendents of Police to implement the said directions of the Hon'ble Supreme Court of India.

That, inspite of the above stated orders, it has come to our knowledge through a reliable source on the 25th April, 2024 that our residential house at New Lambulane, 1st Street, Imphal has been ransacked and all our properties and belongings were looted by some unknown miscreants since the month of December 2023, and moreover our residential house/building has now been illegally intruded and occupied by some unknown miscreants since the last week of February, 2024 although the exact date and time of the unfortunate incident could not be ascertained. The list of the properties or belongings looted by the unknown miscreants are listed herewith for your kind perusal.

I. therefore, request you to kindly look into the matter and take up necessary action at the earliest possible time.
