



Subject: Report regarding burning down of properties by suspected unknown Meitei miscreants.

Sir,

With due respect, I would like to request your good office for taking necessary action regarding the above mentioned subject.

That, I rented a house owned by one (L) Lengpau Vaiphei at New Checkon, Imphal East District, Manipur. However, due to the prevailing communal violence that broke out from 03-05-2023, my family was driven out from the above mentioned address by the Meitei miscreants.

On 04-01-2024 at around 7 p.m., some unknown miscreants trespassed into my rented house and set afire the house in which all my household properties worth estimated Rs. 3 Lakhs were reduced to ashes. However, I could not file a report on time as I am displaced and lack of legal knowledge.

So, in light of the above cited reasons, I request your good office to kindly accept my report and register an FIR Case under relevant section of Law.
