



Subject: Request for lodging an FIR case regarding ransacking and looting of my house in Imphal

Sir,

I beg to state that, I, the undersigned, along with all my family members left our house in Imphal on May 4, 2023 due to ethnic violence in Manipur.

Since then, my house remained inaccessible for the past 11 months. Recently, with due procedures and permission from authorities concerned (DC, Imphal East), I entrusted and authorised one of my friends in Imphal to look after and stay at my house. As such, he along with the police personnel led by Sub-inspector of Porompat Police Station, Imphal East, went to my house located at New Lambulane 3rd Street under Porompat Police Station, Imphal East to inquire and take stock of the situation on April 10, 2024 at around 4 PM, but they found and confirmed that all my belongings and properties had been looted and taken away by unknown miscreants. Even the window panes, toilet doors, geyser, western commode etc. were not spared.

Therefore, I seek your help and request you to kindly register my FIR in the subject matter to initiate necessary legal action against the person (s) involved as per law of the land.
