I have the honour to state the following

That, at around 04:08 PM, unknown miscreant  
numbering around ten enter the polling room  
and smashed the EVM, VVPAT and control unit.

The unique ID of ① CU is ECU EH68842

② BU is EBU EA14629

③ VVPAT is EVTEG00980

They also destroyed all the tables of polling  
officers. This all happens in full view of the  
voters which were in the queue. The miscreants  
also tried to physically harass us but  
we not dodged around.

The miscreants, however, verbally abused  
and harassed.

That, the 44/36, Ukhul (A) Polling Station  
is a women named polling station. The four  
polling officers namely -

I) Yunguila KS

II) Jamichon Tajo



according to the norms and rules provided  
for the polling officers.

That, we consider physical harassment,  
attempt, verbal harassment and disruption  
of E. voting machines an outright abuse of  
power to destroy election norms provided  
the EC and democracy.

Therefore, we fervently pray for taking  
stringent actions against the perpetrators at  
the same time we recommend repoll at  
44/36 Ukhoul (A), Ukhoul Model High school  
polling station.
