Today i.e. 26/04/2024 at around 4.30 pm received an information that on the same day at around 4.15 pm, unknown miscreants numbering about 30 - 40 youths entered and damage the EVM at polling Station No. 47/33-Oinam (A-I), 47/34 - Oinam (A-II), 47/35-Oinam - (B-I) and 47/36 – Oinam (B-II), during the polling hour at Oinam Hill High School. Later, the unknown miscreants escaped.
