Sir,

On 30th April, 2024 in the late evening, information was received that one person from Jiribam was reportedly stopped by some armed miscreants near Seijang- Mongbung village. He was later released by them.

Based on the information, a joint combing operation was conducted today i.e., 01 May, 2024 from 1330 hrs till 1630 hrs. by 39 Assam Rifles and Jiribam district Police in the general area Seijang-Mongbung villages. During the joint combing operation, 12 bunkers were found at Seijang village and destroyed immediately. A search operation was also conducted in the surrounding areas of Seijang village. Result of operation in terms of recovery is as follows:
