Sir,

I have the honour to state that today i.e 02/05/2024 at about 11.15 pm while I along with police team of Special Mobile Patrol Unit, Jiribam were on frisking and checking duty at Leingangpokpi village, Jiribam along NH-37 near Phaitol villgagge, Tamenglong District, 2 (two) explosion sounds of bomb were heard near our police picket of Leingangpokpi village, Jiribam opposite to Phaitol, village. One of the bomb exploded on the road side of NH-37 near our police picket and another bomb exploded on the hill steep of Phaitol village which is about 60 meters from the 1st explosion. It is suspected that the bombs were hurled from the Phaitol village side, Tamenglong District by some unknown miscreants towards the police picket for causing serious casualties to the police personnel. However, luckily there was no casualty.

It is, therefore, requested to kindly take up necessary action against the unknown miscreants.
