

I the undersigned have the honour to state that on 03/05/2023 at around 7:30 pm some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be Kuki Community from different villages entered at Ekou Village, and started damaged my house and house hold properties by burning which was located at Ekou Bazar, Manipur, PS-Saikul.

I could not report in time regarding the incident due to I was engaged in Foreign Language Course in ARTC & School, Shokhuvi (Nagaland) for Myanmar language course SL.no.10 (10<sup>th</sup> April 2023 to 6<sup>th</sup> april 2024).

The following properties were damaged / burnt during the incident:-

1. One Kutcha House - Rs. 10 lakhs.
2. Gold (5 San)- Rs. 75 thousand.
3. Furniture item - Rs. 2 lakhs.
4. Other household properties - Rs.3 Lakhs.

The above mentioned damaged properties are worth about Rs.15,75,000/- (Fifteen Lakhs Seventyfive Thousand)/- only.
