

Subject : Submission of recovered weapons and ammunitions.

Sir,

I am to report the recovery and subsequent submission of cache of weapons , ammunitions and explosive as a part of an operations conducted by a joint team of 16 Assam Rifles and Saikul – PS in accordance with the specific input received on 01 June 2024.

On the aforementioned date specific input was shared by intelligent agency regarding a presence of cache of weapons , ammunitions and explosives in the general area of Wakan ridges. In response to the information, a column of one Officer, one JCO and sixteen others ranks of 16 Assam Rifles assisted by Saikul –PS personnel launched a search operation at 0830 hrs in gen area of Wakan ridges. At around 0945 hrs a suspicious patch covered with foliage was found. The team removed the foliage using a long stick and found cache of weapons and ammunitions.

After conducting a meticulous search for two hours the following weapons, ammunitions and explosives were recovered at 1030 hrs.

- (a) 01 x 7.62 mm AK 56 with mag.
- (b) 01 x 9mm Carbine with mag.
- (c) 02 x 9mm pistol (Country made) with mag.
- (d) 01 x 4mm pistol (Made in India)
- (e) 02 x IED
- (f) 01 x tear smoke shell (chilli)
- (g) 02 x 12 Bore Illumination rds.
- (h) 01 x 2 inch Mor illumination Bomb Mk-2/1 with Bomb case.
- (i) 01 x 2 inch Mor Smoke Bomb Mk-2 with Bomb case.
- (j) 01 x CMG Bayonet
- (k) 14 x tube launching 1A

I would like to submit the recovered weapons, ammunitions and explosives over to your custody for taking up necessary legal action.
