

Subject : Report.

Sir,

With due regards, I beg to state that today i.e. 15/05/2024 at about 04:45 a.m. received a reliable information that some unknown miscreants have stored some arms, ammunitions and explosives at Phouoibi under the jurisdiction of NSK-PS.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 33 AR COB Somrei led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL and a team of NSK-PS under the command of Shri H. Devendra Singh, MPS, Addl. SP(Ops)/TBL and under the overall Supervision of Shri. Rakesh Balwal, IPS, Sr. Superintendent of Police, Thoubal have rushed to the spot immediately and launched a massive operation at 05:30 a.m. by using metal detectors. On searching and found the undernoted articles i.e. 1) 1 (One) no. of MA-3 MK II ASSAULT RIFLE, 2) 1(One) no. of RPG shell 3) 2 (Two) nos. of 81mm mortar shell 4) 3(Three) nos. of detonator 5) 3 (Three) nos. of 36 HE Hand Grenade (can be used as explosive) 6) 3 (Three) nos. of tear smoke shell soft nose 7) 1(One) no. of IED 8) 1 (One) no. of cartridge 38mm Anti-Riot with Rubber Bullet 9) 1(One) no. of tear smoke shell (normal) 10) 2(Two) nos. of 5.56mm ammunition and 11) 40(Forty) nos. of 5.56mm empty case have been seized from the spot at 6:45 a.m. The massive searched Operation was conducted from 05:15 am and continued till 07:45 am of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
