With due respect to OC, Madam, I have the honour to report that on 20/04/2024 at about 4:00 pm, my daughter namely Miss Farinash aged about (16 yrs) D/o Md. Noaman of Thoubal Moijing Leikai was found sitting at the ~~Veranda~~ Veranda of my house. However, after some minutes my daughter was not seen at my house and searched her inside and outside of my house. Later on, it was confirmed that my daughter was kidnapped by one Md. Ishak (17 yrs) S/o (L) Md. Hasan of Thoubal Moijing Leingoiijil to be his wife from near the gate of my house at about 4:30 pm. However, whereabouts of my daughter can't be ascertained till date and she had been kept concealed by the said person.

I therefore, requested to take up necessary legal action against the culprit as per provision of law and rescue of my daughter.
