Late Noor Muhammed of Lilong Nungei Makha Leikai without giving any reason by using his DBBL gun at Lilong Nungei Ningthibikhong Bazar. As a reason of which, my elder brother was received injury on his body and evacuated to Noor Hospital Research Institute, Lilong Khunou. In that the Doctor declared as brought death.
