Today i.e. 15/05/2024 at about 9.00 pm received a reliable information that on the same day at 8.50 pm an unruly mob comprising men and women numbering about 200/300 of Lilong Nungei Meitei Pangal came and gathered at Lilong Nungei Makha Leikai in c/w the FIR No. 44(05)2024 LIL-PS u/s 302 IPC 7 27 Arms Act. Then the said unruly mob cause damaged/destroyed and burnt down some house hold items of one houses of the accused person above reference case namely Md Zabir Hussain aged about 35 yrs S/o. Late Siraj Ahamed @ Sanakhamba of Lilong Nungei Makha Leikai. The unruly mob also disturbed the discharging of lawful duty of the police personnel present at the spot by pelting stone. Later, dispersed the mob at 11. 50 pm.

Hence a suo motto case under FIR No. 45(05)2023 LIL-PS U/S: 147/148/149/353/427/34 IPC has been registered for investigation.
