Sir.

I have the honour to report you that in intervening night of 16/05/2024 and 17/05/2024 (exact timing could not Known) some unknown persons into have entered into my house by climbing the wall southern side. The unknown person/persons then entered my house by breaking the glass window and have taken away my hard earned money including valuable gifts of my deceased mother. The unknown persons forcefully open two almirah (one wooden almirah and another iron almirah) by using tools and kits. They took away 1) One gold necklace of 3 tolah 2) Gold ring of half tolah 3) one ear chain (Nari) of half tolah 4) Ear ring of one and half tolah 5) Nanappi of half tolah. 6) Ear ring of one and half tolah. 7) Raw gold of 1 tolah and 22 gms. 8) cash amounting to Rs 3,20000 9) Another raw gold of 10 tolah and 50x2=100gm, .10) One DVR/ Hard drive of the CCTV camera installed at my house. 11) Wifi Camera, 02 in nos from the first floor of my house. The values of the stolen articles is about 22.67000/- (twenty two lakhs and sixty seven thousand) only. That all our family members were at Calcutta for medical treatment of my wife and the house is under proper lock and key. I came to learnt about the incident as narrated by one of my relatives who has been taking care of my house when we are at Calcutta.

It is therefore, I have requested to take up necessary legal actions agains the unknown culprits.
