


Today i.e. 21/05/2024 at 6.30 pm received a reliable information that on the same day at about 6.20 pm one Truck bearing registration No. MN03T/1405 driven by an unknown driver plying from Sekmai jin side towards Imphal collided with a Vespa, black in colour registration No. Nil ridden by unknown rider which was plying from the opposite direction along Mayai Lambi road near Telecom Office, Khongoi Sorok due to rash or negligent driving on the part of the unknown driver of the Truck. As a result of which the rider of the Vespa succumbed at the spot due to his injury and the pillion rider of the Vespa received injury on his person and evacuated to Hospital for Medical treatment. The two involved vehicles were also partly damaged.

So, a Suo-Motto case under FIR No. 20(5)2024 MIPS U/s 279/338/427/304-A IPC has been registered for investigation.


