Subject: Report on crimes of unlawful displacement, looting, vandalism, arsing and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows:

I am a scheduled tribe belonging to the *Any Kuki Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of T. Chavangphai Village, P.O., P.S. & district- Churachandpur, Manipur.

That, due to the ethnic crisis in the State of Manipur, we deserted our rented house owned by namely, **Joseph Jamhou (8414995103)** on the 3rd of May, 2023 at around 3:30 PM, and during our absence, a mob of Meitei/ Meitei suspected to be members of Arambai Tengool, Meira Paibis and the locals in and around the area attacked our locality, in the process they have looted & vandalized all the household items / movable assets, and burnt down my **Commercial Bajaj Auto bearing Regn. No. MN01 D 9857** along with the rented house on the 5th of May, 2023 at around 7:30 PM located at Sanakeithel, P.O. & P.S.- Lamphelpat, district- Imphal West, Manipur

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about **Rs.30,00,000/- (Rupees Thirty Lakhs)** Only, inclusive of my household items/ movable assets along with my house.

That, 'I am filing this report lately as I was with my family at remote area for months, working as an assistant Truck Driver'.

Therefore, I humbly pray you to kindly register an ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
