Subject: Report on crimes of unlawful displacement, looting, vandalism, arson attacked/ burnt and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Mizo Tribe, which is a recognized tribe under the Constitution of India and a permanent resident of Sanakeithel, Lamphel, P.O. & P.S-Lamphelpat, district-Imphal West, Manipur(enclosed a photocopy of the JAMABANDI).

That, on the 4th of May, 2023 at around 2:00 PM, a mob of armed Meetei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun, Meira Paibis along with the locals in and around the area attacked our locality, in the process they have arson-attacked /torched my vehicles, looted and vandalized our household items/ movable assets along with the residential house and all the important Documents, that includes;

- 1) Installation and fittings of the house (doors, windows, ceiling fans, etc)
- 2) All the movable assets;
 - a) Household items
 - b) Furnitures
 - c) Kitchen items
 - d) Personal belongings
 - e) Electronics & electricals
 - f) Misc

3) Two Wheeler: Bajaj Avenger 220 CC, Blue in colour, whilst, the regn. no. and other details were under the seat of the said vehicle which was torched by the above mentioned miscreants.

4) All the Important Documents of R K Zauva (educational & Service documents) including the supporting documents for Arrears Payment for the 7th Payment Commission which were also vandalised along with the above mentioned assets/ items.
