Mr. Laishram Bidyananda, through his Facebook profile, has been actively spreading misinformation and creating fear among the public regarding the Covid-19 vaccination process. His videos are also widely circulating in Whatsapp.

In light of the serious nature of the situation, I urge you to take strict action against Mr. Laishram Bidyananda to prevent further dissemination of false information related to the Covid-19 vaccination and other health related issues. It is imperative to safeguard the public from misinformation and ensure the smooth functioning of the vaccination program.
