

Today i.e. 8th May, 2024 at 09.00 PM received information that on the same day at @ 08.45 PM a water tanker truck which came to deliver water at Thagmeiband Khoyathong Polem Leikai Relief camp was blocked by some vehicles which was parked on the approach road to Relief camp. So, some unknown persons suspected to be the volunteers of the relief camp flattened the tyres of some vehicles following a heated argument between the local residents of Thangmeiband Khoyathong Polem Leikai arising out of parking space. Later on, an unruly mob was formed at the spot. All of sudden some escort personnel of Hon'ble MLA Kh. Joykishan, Thagmeiband AC came at the spot and fired few rounds.

Hence, a suo-mottu case under FIR No. 276(5)2024 IPS U/s 160/506/34 IPC & 25(1-B) Arms Act has been registered for investigation.
