Subject : Request for lodging FIR regarding house trespass and looting of properties
from my residence located at Canaan Veng, Kabo Leikai Imphal East, Manipur.

Sir,

I have the honour to report the above subject for your kind necessary action. That, I am the rightful owner, inhabit a 3 (three) storey Pucca Building comprising 3 rooms on the ground floor, 4 rooms on the 1st floor, 4 rooms on the 2nd floor and a sizable hall on the 3rd floor. The property is situated at CANAAN VENG Kabo Leikai, Imphal East, near Standard School. PO and PS Imphal west Manipur. It holds the designation of Patta No.1962 and C.S Dag No. 1676, 1705 measuring an area of .038 acres, situated Revenue village No.25(A) Kabo Leikai Nongpok Teshil Porompat Imphal East. Regrettably, due to the outbreak of communal clashes on May 3, 2023, my family and I were compelled to vacate our premises abruptly in the interest of our safety. In our absence, all entry points to our residence were securely locked, with the premises left unattended, as we sought refuge in a safer location at Kangpokpi ward No.2. Disturbingly, I was informed by my neighbours on the morning of May 9, 2024, at around 6. a.m, that unknown miscreants suspected to be from Meitei Community, forcibly broke the locks of my gates and doors on the midnight of May 8, 2024 and looted my hard- earned possessions and valuable household items, including furniture, beds, and other belongings. The estimated value of the stolen items amounts to approximately fifty lakhs (Rs.50,00,000/-).

It is therefore, request you to kindly look into the matter and initiate necessary legal proceedings by registering a case and taking appropriate actions in accordance with the law. Furthermore, I beseech you ensure the safeguarding of my premises and the integrity of the house structure to prevent any further damage or intrusion.
