

Sir,

I have the honour to state that today i.e. 15/05/2024 at about 03:30 pm on receipt of reliable information from our own sources that some gang members possessing arms are threatening the general public of Lamphel Sanakeithel Pukhri Achouba area. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area to conduct a cordon and search operation. On reaching the said area, one unknown person ran away from the area on seeing the security personnel. Due to his suspicious nature, our team chased him and successfully detained near the People Store, Sanakeithel. On spot body search, one pistol marked as "MADE IN USA" NO. 8172" along with one magazine loaded with three nos. of 7.65mm ammunitions, one One Plus Nord 2T 5G mobile handset along with two SIM cards i.e., (i) one Airtel SIM card bearing ph. no. 9233829036 as disclosed by him and (ii) one Jio SIM card bearing ph. no. 8794612978 as disclosed by him and one Aadhaar card recorded in his name were recovered from his possession.

On spot verification, he identified himself as Laishram Rajeshor Singh (30 yrs.) @ Naocha S/o. (L) L. Rajen Singh of Lamlai Awang Leikai, Imphal East District a/p staying at a rented house at Thangmeiband Lourung Purel Leikai owned by one Hidangmayum Geetabali. On being asked about the above recovered arms and ammunitions, he disclosed that the arms and ammunitions were bought from one unknown person whom he met at Nongsum in the month of June, 2023 by paying a sum of Rs. 20,000/-.

Therefore, he was arrested at the spot at 04:30 pm for illegal possession of arms and ammunitions and seized the above mentioned recovered items at 04:40 pm from his possession by observing formalities.

Hence, the arrested person along with the seized items is handed over to you for taking further necessary legal action against him.
