I have the honour to forward herewith a copy of letter No.IN001091/RCDF/PK/2024 dated 10/05/2024 received from illegal underground group namely People Revolutionary Party of Kangleipak (PREPAK) through whatsapp from an unknown miscreant bearing mobile no. 8794871218. Hard copy of the same has been received on 14<sup>th</sup> May, 2024 in the office too for favour of kind information and taking further necessary action.

Further, I am to say that some local dailies/newspapers have already published as headlines in their front pages defaming the service carrier of the undersigned in the vested interest of few notorious persons. At the same time, details under these headlines has been quoted within the threat letter received as mentioned in the above para. Because of such cases, official functions and duties of the undersigned cannot be discharged properly. It has been suspected that some official staff may be involved in this intrigued.

In view to the above facts, I have felt an apprehension for occurring of unwanted circumstances at any instance. It is therefore, requested to kindly make an arrangement to provide adequate security personnel for safeguarding the life and property of the undersigned.
