Today i.e. 18th May, 2024 at 09:00 am, received an information that on the same day one transgender namely Laishram Kumarjit Singh aged about 30 years, S/o Late L. Sarat Singh of Takyel Khongbal Maning Leikai was kidnapped/abducted from Naoremthong Bridge by some unknown armed miscreant(s) and shot on his left leg at Khumbong near Community Health Centre, Imphal West District, Manipur at 01:00 am of today. As a result of which he received seriously injured on his person and immediately evacuated to RIMS Hospital for medical treatment by a team of Patsoi PS.

Hence, a suo-mottu case under FIR No. 291(5)2024 IPS U/s 364/34 IPC & 25(1-B) Arms Act has been registered for investigation.
