I have the honour to state that on 18th May 2024 at around 8.15 p.m. I Naorem Asla Devi daughter of Naorem Krishnamohan Singh of Kakching Wairi Sakal Leikai presently at Lalambung Mahjong Takhellambam Leikai at my home along with Khoizom Aruind Singh and Bijaya Choudhury (Helper). Buntty had come to my place to collect babies diaper which I have purchase after his gym training around 8.10 one mask unknown individual climb on the balcony and came inside the house. Smt. Bijaya Choudhury was surprised and told him who he was the man pull out the gun and pointed at her and beat her then he went and open the door another two men was came inside the house all three were armed with pistol one of the man was not wearing mask one was tall & one was fat & one was white skin out of the three one individual came directly to my bedroom while I was sleeping & looking at facebook on my phone. He told me to get up & pointed the gun at me then he told me to take out all the jewellery (4 Gold ring & 2 Chain and 5 earring) & he told me to open the almirah from the almirah he took all the jewellery (3 Gold ring, 2 Chain & 5 earring). Then he told me to give money but I told that I have no money then Buntty who was watching TV in the next room was interrogated with his eye blindfolded they asked him what is the relation between me & Buntty. Buntty told that I am like his elder sister & we do business

They want that we must keep 5 lakhs rupees by tomorrow (19th May 2024) by 11 a.m. otherwise they will release the video footage & make it viral.

Now I am very worried & my life is at risk & also my character. I requested the police to kindly take all necessary legal action to save me from the armed people. If the video gets viral I don't think I would be able to live in the society.
