Sir,

I have the honour to state that today i.e. 19/05/2023 at around 07:56 pm some unknown persons who came by a Motorcycle have been fired 2 (two) rounds in my People Store, owned by one Salam Sancha (30) yrs S/o S. Santosh Singh of Thangmeiband Khomdram Selungba Leikai, P.O/P.S-Imphal, Imphal West District, Manipur. As a result of which 2 (two) individuals namely 1) Thounaojam Pari (33) yrs S/o Late Th. Ibotombi Singh of Nambol Kabowakching, and 2) Devajit Moirangthem (23) yrs S/o Ibomcha Moirangthem of Langjing Achouba Awang Leikai were received injuries on their persons and evacuated to RIMS Hospital for medical treatment. The front door of the shop was badly damaged due to the said incident.

It is therefore, requested kindly to take up necessary legal action against the unknown person according to law.
