Today i.e 20/05/2024 at 01:20 pm, I came across a series viral on YouTube post on 19th May, 2024 in social media by YouTube channel namely "The Tribal Post" where the post stated that, inspite of the Manipur state government's claim of normalcy returning to the state, several right-wing groups are found harassing non-locals abruptly. In a distressing video, miscreants believed to be associated with Meitei right-winged groups rounded up a group of Indians inside a small bedroom, wherein one of them assaulted them while others recorded his action. The victims can be heard crying and groaning in pain as he continued to physically assault them one by one. The reason for this cannot be ascertained, but it does reflect the lawless situation in Manipur, where individuals or groups associated with certain organizations often take matters into their own hands. It is learnt that the incident was happened against Bangladeshi's students in Kyrgisztan and uploaded "ATN NEWS" hhttps://www.youtube.com/watch?v=pBckJGvzY31.

The YouTube post directly intimidates the Meitei community as-awhole with other communities of the nation. The viral post also induces the general-public and provokes to create enmity between different groups thereby likely to disturb the maintenance of peace and harmony, public-order, and tranquility in the State.

Hence a regular case under FIR No. 298(05)2024 IPS u/s 153-A/505(2)/500/506 IPC has been registered for investigation.
