Subject: Filing of FIR for Cyber Defamation by administrators of Facebook Page "Manipuri Local Group Eramdam gi pot" and YouTube Channel "Meitei Kangleipak"

Respected Sir/Madam,

We, the undersigned, would like to formally lodge a complaint against the administrators of the Facebook page "Manipuri Local Group Eramdam gi pot" and the YouTube channel "Meitei Kangleipak" for defamation and cyber harassment.

We have observed defamatory content posted on both the aforementioned Facebook page and YouTube channel. This content is severely tarnishing our reputation and causing significant mental distress. The details of the defamatory posts are as follows:

The name of the Facebook page, "Manipuri Local Group Eramdam gi pot," has double meanings. One of the interpretations can be a group where immoral posts of local women of Manipur are shared. We have noticed that this Facebook page has been using our photo as the cover photo since May 15, 2022, defaming us in the process. The photo was posted by administrator of the page named Chanchan. Many derogatory comments on the photo have been observed, resulting in significant damage to our reputation. Upon reading the comments, we suspect that there are separate WhatsApp groups for members of this page, which raises our concerns about potential further defamation.

OC/IPS. We would like to note that the photo used by the Facebook page was taken from a regular Facebook post uploaded by Aysha Rajkumari on July 28, 2017.

b. The YouTube channel "Meitei Kangleipak" uploaded a video on May 10, 2024, with the thumbnail "OKTABA SAJAT CHATPA FARE," which means "people who did immoral activities got arrested." Our same photo has been used both in the thumbnail and within the content of the voice narration video, defaming us. The video not only defames us but also leads viewers to criticize and inquire about the incidents, causing us significant mental harassment.

In the description of the video, the administrator of the aforementioned YouTube channel claimed that the information was sourced from various outlets. Consequently, we are concerned that our photo may be used on different platforms and our character has been assassinated.
