According to the recent statement of Manipur which states that 5457 illegal immigrants were found in Kamjong district as of May 7, out of which biometric data had been collected for 5127 and their deportation is under way. However, in point no. VII of the press release of Kuki Inpi Manipur alleges this as deceitful tactic of the Chief Minister and the data aims to unfairly target and stigmatize the Kuki-Zo people.
- 7. Further, the press release alleges Hon'ble Chief Minister of Manipur for continuously spreading fake news, rumours, or misinformation regarding the prevailing situation in the State.

In the last but one paragraph, it alleges the Chief Minister for attempting to stoke the ongoing violence and terms it as 'state-sponsored' in the sentence "CM's deliberate attempt to stoke the violence with his anti-immigration metaphor that Manipur was literally under siege is nothing but a justification for his state-sponsored genocide against the Kuki-Zo people."

In view of the aforementioned false allegations to the Chief Minister of Manipur and reputed Government machineries like the Manipur Police who are trying hard to bring normalcy in the State, it is requested to register an FIR against the President/ Secretary of Kuki Inpi Manipur and Jangkhaolun Haokip, Secretary Information & Publicity, Kuki Inpi Manipur at your Police Station at an early date.
