

With greatest respect, I beg to state that I have been actively participated in the promotion of handloom and handicraft produced in our home-state for considerable period of time. Being a part of such promotion of handloom and handicraft products, I had attended the inaugural function of Kumarjit Laishram Bridals, Handloom Array run by Kumarjit Laishram which were also attended by many other invitees. On the said event, several photographs were taken by many photographers and are now available on Facebook and other social media pages.

On 19.05.2024 evening, I have come across several facebook posts with derogatory captions shared by more than 1000 facebook users. I would like to state that one facebook account under the name "S Ahongsngbm" started posting one of the photographs taken in the above-mentioned event and shared with a caption "*kakching gi hero heroine tpna2 haidoraklani, Somdna yum mei chak e echin enao mayam amana ema leibak ki thawai thari aduga mapi mapa oiriba moina twriba sajjat tukachei moisu cheirak pifam thok e mari leinaba singna. Achum aral thiraga*" (screen shot enclosed). 

The facebook caption and photograph which was posted on social media was designed with a criminal motive by the said user namely S Ahongsngbm to injure, insult and harm my character and reputation and to create a doubt to the

general public by relating to the sensitive issue that has been taking place in the recent days.

The viral post mentioned above has caused serious threat to my life and reputation. I am, therefore, making this complaint to your goodself to take up necessary legal action against the persons involved in publishing the posts.


